



Business Exhibit Agreement

_____ (Hereinafter referred to as Exhibitor) wishes to participate in the Home and Garden Show 2012 to be held on March 10, 2012 from 10 a.m. to 6 p.m. and March 11, 2012 from noon to 6 p.m. at The Mall in Hays, Kansas, and agrees to the following:

- (A) Exhibitor recognizes The Hays Daily News (Hereinafter referred to as Sponsor) as the sponsor of the Home and Garden Show '12.
- (B) Exhibitor recognizes The Mall @ Hays (Hereinafter referred to as Contractor) as the contractor and specifically excludes all offer of exclusivity of any category of business.
- (C) The solicitation of the Home and Garden Show '12 participants is the sole responsibility of the Sponsor, pending the approval of the Contractor.
- (D) Both the Contractor and the Sponsor agree to make every effort to allocate the Exhibitor the position indicated in this Agreement.
- (E) Exhibitor agrees to pay the Sponsor a fee of \$225 per 10 by 15-foot booth space.
- (F) Exhibitor must furnish The Hays Daily News two (2) copies of a certificate of general liability insurance in the amount of \$1,000,000 listing The Mall @ Hays Dial Properties Co., and The Hays Daily News as additional insured. Questions can be referred to Jan Tinkel 785-628-1081.
- (G) Exhibitor shall conform to all federal, state, and city laws and mall regulations.
- (H) Exhibitor acknowledges his total responsibility for his display(s) and for the actions of his employees, agents, contractors or subcontractors, in the area surrounding the display and will maintain direct control over all activities in his exhibit area.
- (I) Exhibitor agrees to set up between the hours of 6 p.m. and 11 p.m. on March 9, 2012 or between the hours of 7 a.m. and 10 a.m. on March 10, 2012 and agrees not to remove his display before 5:00 p.m. on March 11, 2012.
- (J) Exhibitor's personnel must man booths during all show hours unless prior arrangements have been made with Contractor and Mall personnel.
- (K) Electricity and water are not available in all areas. Exhibitor requiring either or both must inform the Sponsor, and every effort will be made to ensure their availability.
- (L) The exhibitor must supply electrical cords and in traffic areas cords must be taped to the floor with duct tape unless otherwise approved by The Mall.
- (M) Displays must not exceed 8 feet in height.
- (N) No item may be attached to The Mall property.
- (O) No inflated balloons may be used in displays or distributed from display.
- (P) No raffle, or lottery type tickets may be sold, and no games of chance conducted from display.
- (Q) Sirens, bells, amplifiers, flashing lights, or any equipment causing excessive noise or annoyance is expressly forbidden.
- (R) No tents or tarps will be allowed; tops of booths must be open at all times.
- (S) Exhibitor is responsible for cleaning area around booths at the conclusion of the event.
- (T) Sponsor and/or Contractor will provide one table and two chairs for the event.
- (U) Exhibitor will provide their own table covering.

The exhibitor agrees to indemnify and hold harmless The Mall @ Hays, Dial Properties Co., News Publishing Company Inc., and their agents, and employees from all claims, damages, and losses and expenses including reasonable attorney's fees in any case where it shall be necessary to file an action, (1) arising out of the performance of the work herein which is one of bodily injury, illness or death or property damage, including loss of use, and (2) caused in whole or in part by the exhibitor's negligent acts or failure to act or that of his agents, employees, contractor or subcontractor or anyone employed by them from whose act the Exhibitor may be liable.
